This is the North Florida Economic Development Partnership's (NFEDP) Third Quarter Report for the 2019 Rural Regional Development Grant-D0134. The Partnership continues to enhance the region's economic development recruitment efforts in our leadership role through outreach, shared resourcing, world-wide marketing and various forms of administrative and technical assistance to our stakeholders.

The NFEDP has been working with the other two Rural Areas of Opportunity to build a strong consensus to strengthen our efforts to unify our common goals to the benefit of all rural Florida under the auspices of the Florida Rural Economic Development Association (FREDA). The date has been set for the 2020 Rural Summit which will be April 30 thru May 2, 2020 at the Hilton Orlando Lake Buena Vista at Disney Springs in Orlando.

The NFEDP website enhancement project funded by USDA has made a huge advance in project goals during the 3<sup>rd</sup> quarter. Marketing Alliance in combination with NFEDP staff photographed and videoed numerous asset locations throughout the 14-county region. A 5-day shoot was conducted by a three-member crew of professional photographers traversing the entire region. Ground shots as well as drones were used to capture the NFEDP's economic assets. A draft of the new website video is scheduled to be debuted at the December 6, 2019 full-board meeting.

Technical assistance has continued to be a valuable component and service to all the counties. NFEDP staff has assisted numerous counties with proposals received from site consultants, grant applications for the Florida Growth Grant Fund, and Rural Infrastructure Fund. Additionally, the NFEDP has assisted a number of communities' work through their contract deliverables and Scopes of Work.

The NFEDP has expended \$132,862.33 since the Effective Date, February 7, 2019, and has accomplished no less than one hundred percent of its objectives in the Scope of Work. At this time, there have been no material changes in the Project Budget.

### I. Welcome and Meeting Call to Order

Chairman Todd Gray, NFEDP Chair, Commissioner Gilchrist County

### II. Welcome and Introduction from Host County

Chairman Gray called the meeting to order at approximately 9:05 a.m. Chair Gray introduced Hamilton County Commissioner, Beth Burnam, who welcomed everyone and then introduced Rhett Bullard, Hamilton County Development Authoriy (HCDA) Attorney. Mr. Bullard introduced Chadd Mathes who is the new HCDA Executive Director.

### III. Pledge of Allegiance and Invocation

NFEDP Chair Todd Gray called the meeting to order at approximately 9:05 a.m. He requested NFEDP Past Chair Darryl Register to give the Invocation and requested for everyone to stand for the Pledge of Allegiance.

### IV. Comments from Public.

Chairman Gray asked for comments from those in attendance. No one requested to make any comments.

### V. Approval of September 6, 2019 Meeting Minutes

Chairman Gray recognized NFEDP Executive Director, Jeff Hendry, who explained Secretary Diane Head was not present due a death in the family. Jeff stated the September minutes had been sent out by email prior to the meeting for review and a motion was needed to approve. Motion was made by Brian Bergen, seconded by Glenn Hunter. The minutes were approved unanimously.

### VI. Treasurer's Report

Chairman Gray recognized NFEDP Treasurer Dave Pieklik to present the Treasurer's Report; he shared the Treasurer's Report had been forwarded out via email before the meeting and noted the balance for the board. Dave Pieklik stated he had reviewed the report and agreed with it. He stated Jeff Hendry had made him aware of a couple of comments he wished to make to the board. Mr. Hendry stated that although the current balance showing is approximately \$193,579 the invoice to DEO for the third quarter reimbursement is approximately \$33,775 and a USDA request for reimbursement has been sent for \$17,000-\$18,000. Mr. Hendry indicated when these payments are received by the end of December or early January the balance should be approximately \$246,000. The Treasurer's Report was unanimously approved. (Motion to approve by Commissioner Gene Hall and seconded by Glenn Hunter).

## VII. Consideration of Recommended Vendor for NFEDP Sites and Buildings Database for the NFEDP Website

Mr. Hendry explained the purpose of the Intent to Negotiate for a new Sites and Buildings database for the NFEDP website. There were only two companies that responded, GIS Planning and GIS WebTech both of which provided in-person presentations for IOG/NFEDP staff (Jeff Hendry, Mike Rykco, Diane Scholz), and by Go-To-Meeting to all other review committee participants on December 2, 2019. Those on the phone were: Victor Leotta (Leotta Location+Design), Diane Head (CareerSource North Florida), Marc



Hoenstine (Duke Energy), Mary Demsey (FPL), and Nancy Blume-Heinz (VisionFirst Advisors). Chair Gray entertained a motion: David Pieklik motioned/ Brian Bergen seconded.

### VIII. Consideration of RRDG 3r<sup>d</sup> Quarter Report and Submission.

Chairman Gray recognized Diane Scholz to make comments regarding the Rural Regional Development Grant (RRDG) 3r<sup>d</sup> Quarter report and request for reimbursement. Ms. Scholz provided an overview of the expenditure of funds in the amount of \$33,775 for technical assistance services and marketing efforts. Ms. Scholz explained we are nearing the end of this grant and therefore it's time to prepare a 2020 grant application and we will need letters of support from all the counties. She made the Board aware the remaining balance of approximately \$16,000 is all that's left for the 4<sup>th</sup> quarter. The Chair requested a formal motion to approve. A motion was made and seconded and the vote was unanimous to submit to DEO for reimbursement (Brian Bergen/Dave Pieklik).

### IX. Presentation: NFEDP Website Enhancement

John Abbate, Marketing Alliance CEO, briefly explained Marketing Alliance's history with the NFEDP for the past 5 to 6 years. Additionally, he introduced his associate and son, Michael Abbate. Mr. Abbate told everyone about the website enhancement process and some samples of the videos and photography produced during the 5-day filming of the region. He explained how the digital message is sent in-lieu of text which is the current preferred format by website experts. The company is in the process of reviewing the newly developed NFEDP overview video which is still under final completion. He reminded everyone about the business directory feature of the newly enhanced website and reminded everyone the need to provide the local business information for each of their counties and the need to submit the information to Jeff Hendry or Diane Scholz.

### X. Presentation: M-CORES Update

Chair Todd Gray prefaced the presentation by explaining that the M-CORES FDOT project is somewhat controversial among some of the NFEDP counties, but in fairness everyone needs to listen to the presentation facts and not to be critical of the messenger, Ryan Asmus, Florida Department of Transportation-Project Lead for the Suncoast M-CORES Program, provided a factual overview of the M-CORES project and the process and likened to when in 1950 the Interstate System was undertaken. The Florida Legislature passed Senate Bill 7068, the Multi-use Corridors Of Regional Economic Significance Bill. The project can have a positive impact on economic development, broadband infrastructure improvements, protecting wildlife and native species, to encourage planning for the future. FDOT has divided the process into three corridors and is expected to have many, many significant improvements in infrastructure and transportation enhancements.

### XI. Presentation: Florida Transportation Plan (FTP)

Jim Halley, Florida Department of Transportation-Statewide Planning Coordinator, presented a slide presentation on the Florida Transportation Plan process to help inform participants on the need for their input and their participation in the process. He emphasized that the plan impacts all communities big and small, rural and urban, and economically thriving and those in distress. "Be A Part" is the FTP slogan to encourage participation by all Floridians. Mr. Halley announced the FTP Planning Exchange Conference will be held April 22-22 in Orlando and provided Save-the-Date handouts.



### XII. Presentation: Update: Rural Counties Days, January 15-16, 2020, Tallahassee

Chairman Gray recognized Patricia Evans, Chair of the Bradford County Economic Development Taskforce who spearheaded the first Rural Counties Day initiative in 2019. Mrs. Evans indicated that the event had been expanded to include the entire footprint of the NFEDP region which caused the need for the group to ask for assistance from the NFEDP for numerous administrative and technical support. Currently, nine counties are participating in the 2020 Rural County Day events on January 15<sup>th</sup> and 16<sup>th</sup> with an anticipated 1,500 attending the fish-fry. Darryl Register, Immediate Past Chair, reminded everyone that in 2019 the NFEDP participated in a sponsorship amount of \$1,500 and asked that the board consider the same for 2020. Darryl Register made a motion; Sarah Owen seconded; and the motion passed unanimously.

### XIII. Update: Rural Economic Development Summit

Jeff Hendry provide updates and a handout to those in attendance. He announced that CareerSource is partnering with FREDA to conduct the 2020 Florida Rural Economic Development Summit. He stressed the importance of making your hotel reservations early to insure lodging in the host hotel. He explained additional rooms may be made available if possible, but often times the host hotel does not more rooms based on other events that have been booked in advance. He reminded everyone that NFEDP Scholarships will be available. Jeff also reminded everyone about the need and opportunity for sponsorships in support of the Summit and he will be reaching out to them very soon.

Agenda went off schedule by Diane Scholz who informed the members of the importance of the copies of the Strategic Plan that are available at the registration table and they can be a resource for your grant writers. All handouts were taken.

### XIV. Presentation: Status of Hemp Issues

Bryan K. Benson, Deputy Director, Division of Plant Industry, Florida Department of Agriculture and Consumer Services explained the basic structure of the new Hemp Initiative in Florida in the new Division of Cannabis, and the structure of licensing growers, certifying seeds, monitoring crops, and testing harvests. He spoke in general terms about the laws and that there is very little flexibility if any in the federal laws and guidelines. Mr. Benson provided tentative plans for modifications to some of the laws which will not occur until next year. Growers will have to be fingerprinted in order to apply for a license. No limitations on number of acres a grower can cultivate, but the level of THC will be monitored based on the area.

Agenda went off schedule due to introducing Representative Loranne Ausley making an unannounced visit to the NFEDP Board. She made general remarks about rural issues of which she had been made aware and said she would available through lunch to speak with individuals. (Rep. Ausley is running for termed-out Senator Montford's seat.)

### XIV. Presentation: 2020 Legislative Session Preview

Mike Grissom, Senior Government Relations Director, Becker Lawyers, PA, referenced his history with EFI and knowledge of all the issues effecting rural. He stated that if the FL legislature does not act this year, the Qualified Target Industry rebate will sunset. He provided a very brief summary of the status of the legislature, but then he really wanted to hear questions from the audience to know what was on their minds. General questions covered funding issues and expressed the importance of the audience making their issues and concerns known to their legislators. Mr. Grissom provided the history of the Rural Regional



Development Grants need to increase to \$250k, and the previous efforts to get that done. He made additional comments regarding what it takes to accomplish those advocacy efforts.

### XV. EFI Rural Marketing Project Update

Chairman Gray recognized Jeff Hendry who reminded everyone as to what is expected and that only one submission so far had come close, but it lacked economic development photos. Diane Scholz added that the grant funds are provided by Enterprise Florida, so the focus is to market your economic development assets, not tourism. The quality of life photos add value to the brochure in respect to a great place to live and work but should not be the only photos.

### XVI. Roundtable: Local/Regional Projects and Other Issues

- Glenn Hunter, Director Columbia County Economic Development Department, provided updates regarding economic development projects within Columbia County. He announced the Groundbreaking of the MEGA Site Rail Spur on December 12<sup>th</sup>, which was funded by a FJGGF award and a legislative special appropriation. Werner Trucking will begin construction on their new site on Bell Road Corridor based on all of the new infrastructure funds they have garnered from multiple funding sources.

- Darryl Registered, Baker County Chamber of Commerce, announced huge rail transportation improvements at their industrial park in partnership with Florida Gulf Coast and Atlantic Railroad which includes a trans-modal facility, a switching station, a large railyard and rail spur. He also announced a marijuana growing and processing facility which is using an old factory building. Acreage Holdings based in New York but traded on the Canadian Exchange. They are currently remodeling the building where the entire process will be under roof.

- Caroline Evans announced USDA education grant awards which had been made to NFEDP counties: Levy, Madison, and Washington County.

- Patrick Wnek, NEFEC, announced NEFEC had received a \$4 million grant award from US DOE for literacy. They intend to utilize it throughout the region.
- Brian Bergen, Putnam County Chamber of Commerce, VP Economic Development, updated everyone on Project Egg Shells. They have almost completed their renovations of the old spec building they purchased from Putnam County BOCC.
- LaWanda Pemberton, Taylor County Administrator, announced construction will start on the old Florida Georgia Railroad \$8.67 million award which the FGCA RR will provide the 50% match.




