This is the North Florida Economic Development Partnership's (NFEDP) Third Quarter Report for the 2020 Rural Regional Development Grant-D0166. The Partnership continues to enhance the region's economic development recruitment efforts in our leadership role through outreach, shared resourcing, world-wide marketing and responding to the needs of the 14-county region due to the COVID-19 virus, and various forms of administrative and technical assistance to our stakeholders.

The Florida Rural Economic Development Association (FREDA) in conjunction with the NFEDP continues to adjust plans for the Florida Rural Economic Development Summit which originally planned for April 2020, then November 2020. There is now a tentative date in late March early April 2021 for the Summit to held in Orlando.

The NFEDP website enhancement project funded by USDA is complete, the Campaign Launch has been completed by Marketing Alliance, and Marketing Alliance presented some very impressive positive results the NFEDP staff.

Technical assistance has continued to be a valuable component and service to all the counties. The NFEDP prepared Rural Community Development Revolving Loan application for \$2.5 million, a Rural Infrastructure Fund-Total Participation grant for \$1,103,320, and numerous small grants for multiple counties for approximately \$350,000.

The NFEDP has expended \$129,654 since the Effective Date, February 8, 2020, and has accomplished no less than one hundred percent of its objectives in the Scope of Work. There were two scholarships funded for virtual attendance for training with the IEDC and one with the Florida Chamber of Commerce.
